

## TERMS OF USE

Last updated: November 7, 2024

### 1 - Definitions:

Seller: *Nizus Online Pilot Training Inc.*

Site nizus: nizus.com, nizus.ca

User or purchaser: any person using the services offered by the seller (that is to say, anyone who connects to the site or who purchases a service on the site)

### 2 - General:

In one part of the site content nizus (especially in these conditions of use), male gender was adopted for grammatical needs. However, it will be considered as a generic term for the masculine and the feminine.

If any part of the contents of these Terms of Use is in disagreement with the laws of British Columbia and Canada, the latter shall prevail.

This document is to define the terms and conditions under which the one hand, *Nizus Online Pilot Training Inc.* provides its users the website and the services therein and, secondly, the way in which the user accesses the site and uses its services.

These terms and conditions govern the relationship between line training of *Nizus Online Pilot Training Inc.* and users. The user and the purchaser of the services offered by *Nizus Online Pilot Training Inc.* are required to be familiar with these terms and conditions. This also applies to the Partnership users.

11 - Partnership:

If a flight training unit (or any other organization or person) uses the identification number associated therewith by nizus partnership system, it will:

- Respect these terms of use;
- Enforce these terms of use to persons to whom it provides its identification number;
- Immediately advise *Nizus Online Pilot Training Inc.* if it finds that these conditions of use are not respected by a *nizus* user;
- Immediately notify *Nizus Online Pilot Training Inc.* of anomalies that have been reported about the use of the website *nizus*.

The money remitted by *nizus* to the flight training unit (or any other organization or person) using identification (ID) number is the percentage, established between *Nizus Online Pilot Training Inc.* and the said flight training unit (or any other organization or person) of the amount of all subscriptions (before taxes) associated with its ID for a period of one (1) year beginning on the first of February of each year and ending on the last day of January of each year. The corresponding amount will be paid to the said flight training unit (or any other organization or person) as soon as possible after the last day of January of the ended year, but within a maximum of six months.

A contract wrote and signed by *Nizus Online Pilot Training Inc.* and signed by this flight training unit (or any other organization or person) may modify this part (that is to say the part "11 - Partnership") of these conditions of use.

12 - Account Closure:

*Nizus Online Pilot Training Inc.* reserves the right to terminate access to nizus website or other products or services without notice to the user if (for example and without limitation):

- There is a regulatory or legislative change that limits the seller's ability to provide a website;

- User abuses the services nizus or acts in violation of these Terms of Use.

### 13 - Showing prices for the services available on the site nizus:

Information on services and prices presented by *Nizus Online Pilot Training Inc.* are required mandatory, expect error. When a price is given, it is always given in canadian dollars (CAD), and it is assumed to be without taxes (HST, GST, PST). When two awards are presented for a product, it is assumed that the lowest price is excluding taxes and the highest price includes the tax or taxes applicable to the province of the buyer.

Every payment is made via Stripe, a secured payment platform independent of *Nizus Online Pilot Training Inc.* *Nizus Online Pilot Training Inc.* have no access to the payment data used on the website nizus. *Nizus Online Pilot Training Inc.* disclaims all liability for these payments.

Following the payment, the buyer receive a detailed invoice for the purchase he made at the e-mail address associated with his nizus account.

### 14 - Subscriptions offered by the site nizus:

The access of the subscriptions available to the user are limited in time but not in numbers. Information about duration and description of the content of the subscriptions are indicated in the "Training Programs" page of the website nizus and can be consulted before any payment. When a user purchases a subscription, it has a certain time limit to enjoy it. If, within a period of zero to seven days inclusive after purchasing a subscription, the user decides to extend it, it can increase the time limit to complete the payment to go to a higher subscription (for the same stage). However, after seven days, the user wanting to increase its time limit must pay the full desired new subscription. In the latter case, the time corresponding to the new subscription will be added to the time of the old subscription.

### 15 - Letter of recommendation

To get a letter of recommendation, the applicant must meet certain conditions, depending on their situation.

Note that no exceptions will be made. To get a letter of recommendation, the applicant must meet all the following requirements.

#### a. Getting a first letter of recommendation for the full examination

To request a first letter of recommendation from nizus, the applicant must, on nizus:

- Have validated the appropriate full course (meaning that you have taken all the sections of all the chapters of all the modules)
- Have spent the minimum hours requested on the appropriate course and the practice examinations



- Have passed all the quizzes (your scores are not counted) under the "Course" heading
- Have finished all the practice examinations (module examinations and complete examinations) under the "Examinations" heading
- Have obtained a score of at least 80% on at least 3 full examinations

The applicant must also attest that he has spent at least 10 hours in flight on board an aircraft, or that he holds a Pilot Permit — Ultra-light Aeroplane.

b. Getting a second or later letter of recommendation for the full examination

In the event of a complete examination failure, the applicant will need to request another letter of recommendation.

In this situation, the applicant must once again get a score of at least 80% on at least 3 full examinations on nizus before he requests a letter.

c. Getting a letter of recommendation for a partial examination

If the applicant only partially pass their examination (with a score of at least 60% on the examination, but under 60% on one or more modules), the applicant will need to request a letter of recommendation for a partial examination.

To get such a letter, the applicant must:

- Have already received a letter of recommendation for the full examination from nizus
- Obtain a score of at least 80% on at least 3 module examinations on nizus for each module that he did not pass on your TC examination

Note: The time that is recorded within a single chapter has a maximum duration. For example, if the applicant spends 40 hours in a single chapter, the time recorded for the letter of recommendation will not be 40 hours but the defined maximum duration.

Important: If the applicant has not previously gotten a letter of recommendation for a full examination from nizus, he will not be able to request a letter of recommendation for a partial examination.

16 - Repayment and cancellation policy:

If a purchase is mistakenly made on nizus' website, the buyer can ask a complete repayment of the purchase within seven (7) days following the purchase. The repayment request must be send to [service@nizus.com](mailto:service@nizus.com), with the corresponding invoice. The repayment will be accepted and completed only if the buyer did not take advantage of the purchase (for example, by performing a training examination). As a result of the repayment, the buyer will have no longer access to the service offered by the purchase.

*Nizus Online Pilot Training Inc.* offers no other terms of repayment and does not guarantee any refund or compensation to the user.

17 - Communications:

When the user uses the nizus website or when sending emails to *Nizus Online Pilot Training Inc.* It communicates electronically with the seller. Therefore, he agrees to receive electronic

#### 18 - Use and Disclosure of information collected:

When using nizus, the user declares to have read and accepted the Legal Notice of *Nizus Online Pilot Training Inc.*

At the request of flight training units, or systemically to the partners of nizus, *Nizus Online Pilot Training Inc.* reserves the right to provide certain information collected from users of the site nizus. This information (such as name and surname of the user, its statistics, the exams written on nizus, the time taken to conduct an exam, the date of the exam...) is provided to training units in order to help them to sign the letters of recommendation required to write a Transport Canada examination. When using nizus, the user accepts that *Nizus Online Pilot Training Inc.* provides such information to flight training units. If the user does not want such information to be sent to its flight training unit, he shall notify *Nizus Online Pilot Training Inc.* by email. Once *Nizus Online Pilot Training Inc.* has responded to this email, this information will not be disclosed anymore to training units.
